



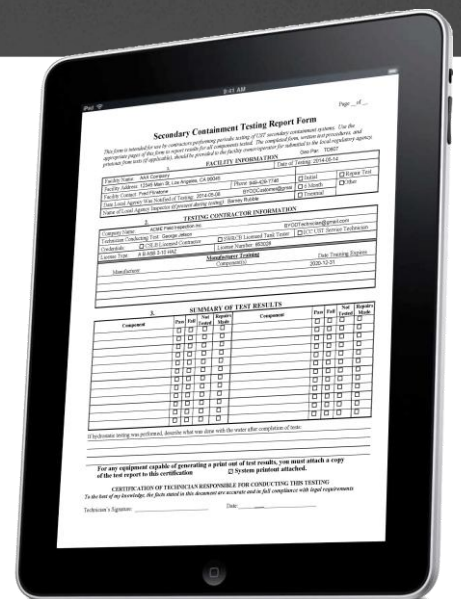

The solution has two separate modules:

- Mobile data capture module that allows your field technicians to quickly and accurately complete inspection forms and work orders, even when they don't have an online connection.
- Web-based Compliance Reporting System that enables an automated workflow and approval processes for your inspections and includes cloud-based easy-to-use portal that allows your customers online access to their documents including permits, testing schedules, Testing Reports and Results, SIR Reports, Certificates of Compliance, Employee Training Results, Site photos, and site diagrams/blueprints.



Capabilities:

- Pre-fills and automatically sends testing/inspection forms and the work order with customer, facility, and other pertinent information to make the process of completing the forms faster and more accurate with fewer errors.
- The ability for your field technicians to easily complete testing/inspection forms and work orders in the field on a tablet. Easily include customer electronic signatures, photos right into the forms.

- Automatically validates that your field technician has the proper certification and training to perform the required test or inspection prior to dispatching the technician.
- Automatically pre-fills and creates the following documents/links for each inspection.
 - Link to add the appointment to a Google or Outlook Calendar
 - Link with Directions to the nearest Hospital Emergency Room
 - The correct Pre-filled testing and inspection documents including documents like the SB-989, Monitor Certifications, Work Order etc.
- Includes a workflow and approval process for inspections. Once the inspection is approved by a supervisor or manager, a final document package including a cover letter is automatically created, archived, and can be emailed to your customer.
- Training Record - Tracks training courses completed, expiration dates, notifies recipient and manager of expiring training.

The optional Web-based Compliance Reporting System is a cloud-based workflow and document storage solution that manages your overall workflow and approval processes, emails inspections automatically, stores all of your inspection documents as PDF's electronically, and even has dashboards and reporting that allows you to better manage your business.
